MODE OF MEETING

The RCUIDS Holders Meeting of the Company will be conducted on a virtual manner through live streaming from the Broadcast Venue and online remote voting using the Remote Participation and Voting facilities provided by Tricor Investor & Issuing House Services Sdn. Bhd. via its **TIIH Online** website at <https://tiih.online>.

The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act, 2016 which requires the Chairman of the meeting to be present at the main venue of the meeting.

REMOTE PARTICIPATION AND VOTING FACILITIES ("RPV")

Redeemable Convertible Unsecured Islamic Debt Securities Holders ("**RCUIDS Holders**") and/or proxy(ies) and/or corporate representative(s) and/or attorney(s) **WILL NOT BE ALLOWED** to be physically present at the Broadcast Venue on the day of the RCUIDS Holders Meeting, instead are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "**participate**") remotely at the RCUIDS Holders Meeting via the RPV provided by Tricor Investor & Issuing House Services Sdn. Bhd. via its **TIIH Online** website at <https://tiih.online>.

RCUIDS Holders who appoint proxies to participate at the RCUIDS Holders Meeting via RPV must ensure that the duly executed Form of Proxy is deposited in a hard copy form to the business address of Malaysian Trustees Berhad at Level 11, Tower 3, RHB Centre, Jalan Tun Razak, 50400 Kuala Lumpur ("**Business Address**") or by electronic lodgement via **TIIH Online** website at <https://tiih.online> not later than **2.00 p.m. on Saturday, 12 October 2024**. **Faxed copies of the duly executed form of proxy are not acceptable.**

Authorised representatives of corporate RCUIDS Holders must deposit their original or duly certified certificate of appointment of authorised representative at the Business Address not later than **2.00 p.m. on Saturday, 12 October 2024** to participate via RPV at the RCUIDS Holders Meeting.

Attorneys appointed by power of attorney are to deposit their power of attorney at the Business Address not later than **2.00 p.m. on Saturday, 12 October 2024** to participate via RPV at the RCUIDS Holders Meeting.

A RCUIDS Holder who has appointed a proxy or authorised representative or attorney to participate in the RCUIDS Holders Meeting via RPV must request his/her proxy or authorised representative or attorney to register himself/herself for RPV at the TIIH Online website at <https://tiih.online>.

RCUIDS Holders who are unable to participate in this RCUIDS Holders Meeting may appoint the Chairman of the meeting as his/her proxy and indicate the voting instructions in the Form of Proxy.

Refer to the tutorial guide posted on the homepage for assistance. • Registration as a user will be approved within one (1) working day and you will be notified via e-mail. • If you are already a user with TIIH Online, you are not required to register again. You will receive an e-mail to notify you that the remote participation is available for registration at TIIH Online.
(b) Submit your request to attend RCUIDS Holders Meeting remotely	<ul style="list-style-type: none"> • Registration is open from 2.00 p.m. on Friday, 20 September 2024 until the day of the RCUIDS Holders Meeting on Monday, 14 October 2024. RCUIDS holder(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the RCUIDS Holders Meeting to ascertain their eligibility to participate at the RCUIDS Holders Meeting using the RPV. • Login with your user ID and password and select the corporate event: “(REGISTRATION) CAPITAL A RCUIDS HOLDERS MEETING 2024”. • Read and agree to the Terms & Conditions and confirm the Declaration. • Select “Register for Remote Participation and Voting”. • Review your registration and proceed to register. • System will send an e-mail to notify that your registration for remote participation is received and will be verified. • After verification of your registration against the General Meeting Record of Depositors as of 4 October 2024, the system will send you an e-mail after Saturday, 12 October 2024 to approve or reject your registration for remote participation. <p><i>(Note: Please allow sufficient time for approval of new user of TIIH Online and registration for the RPV).</i></p>

(c)	Login to TIIH Online	<ul style="list-style-type: none"> Login with your user ID and password for remote participation at the RCUIDS Holders Meeting at any time from 1.00 p.m., i.e. one (1) hour before the commencement of the meeting on Monday, 14 October 2024 at 2.00 p.m.
(d)	Participate through Live Streaming	<ul style="list-style-type: none"> Select the corporate event: “(LIVE STREAM MEETING) CAPITAL A RCUIDS HOLDERS MEETING 2024” to engage in the proceedings of the RCUIDS Holders Meeting remotely. If you have any question for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will endeavour to respond to questions submitted by remote participants during the RCUIDS Holders Meeting. If there is time constraint, the responses will be e-mailed to you earliest possible, after the RCUIDS Holders Meeting.
(e)	Online Remote Voting	<ul style="list-style-type: none"> Voting session via the RPV commences from 2.00 p.m. on Monday, 14 October 2024 until a time when the Chairman announces the completion of the voting session of the RCUIDS Holders Meeting. Select the corporate event: “(REMOTE VOTING) CAPITAL A RCUIDS HOLDERS MEETING 2024” or if you are on the live stream meeting page, you can select the “GO TO REMOTE VOTING PAGE” button below the Query Box. Read and agree to the Terms & Conditions and confirm the Declaration. Select the CDS account that represents your RCUIDS units. Indicate your votes for the resolutions that are tabled for voting. Confirm and submit your votes.
(f)	End of remote participation	<ul style="list-style-type: none"> Upon the announcement by the Chairman on the closure of the RCUIDS Holders Meeting, the live streaming will end.

Note to users of the RPV:

- Should your application to join the RCUIDS Holders Meeting be approved, we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of the RCUIDS Holders Meeting will indicate your presence at the virtual meeting.

GENERAL MEETING RECORD OF DEPOSITORS (“ROD”)

(b)	Proceed with submission of Form of Proxy	<ul style="list-style-type: none"> • Login to TIIH Online at https://tiih.online • Select the corporate event: “CAPITAL A RCUIDS HOLDERS MEETING 2024 – Submission of Proxy Form”. • Read and agree to the Terms & Conditions and confirm the Declaration. • Proceed to download the file format for “Submission of Proxy Form” in accordance with the Guidance Note set therein. • Prepare the file for the appointment of proxies by inserting the required data. • Proceed to upload the duly completed proxy appointment file. • Select “Submit” to complete your submission. • Print the confirmation report of your submission for your record.

- RCUIDS Holders can proceed to vote on the resolutions via RPV at any time from the commencement of the meeting at **2.00 p.m. on Monday, 14 October 2024** but before the end of the voting session which will be announced by the Chairman of the meeting during the RCUIDS Holders Meeting. - Upon completion of the voting session for the RCUIDS Holders Meeting, the Scrutineers will verify and announce the poll results followed by the Chairman’s declaration whether the resolutions are duly passed.
